The Digital Organizations & Society (DOS) Chair produces and disseminates scientific knowledge on the impact of digital technologies on individuals, organizations, health, and society.

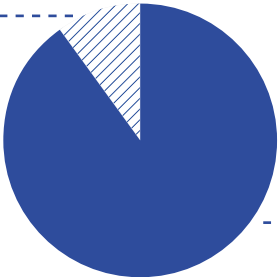


Excellence Scholarships in 2024

Benefit from tax advantages

The GEM Foundation is hosted by the Fondation de France, which is recognized as a public utility. Your donation benefits from the tax advantages provided under Article 238 bis of the French General Tax Code.

Corporate Sponsors:

60% of the donation amount is deductible from French corporate tax, up to 0.5% of annual revenue. For a €50,000 donation, it will cost your company only €20,000 after deduction.

Individual Donors:

- 66% of the donation amount is deductible from French income tax, up to 20% of taxable income. A €1,000 donation costs you only €340 after deduction.
- 75% of the donation amount is deductible from French wealth tax (IFI), up to €50,000 in deductions. A €1,000 donation costs you only €250 after deduction.

International Sponsors:

For sponsors based abroad, to benefit from tax advantages in their home country, the Fondation de France has partnered with Transnational Giving Europe (a network of twenty European countries) and Friends of the Fondation de France (USA) to encourage cross-border philanthropy.
